

## **Noggin Website Privacy Policy**

This Privacy Policy describes how Noggin collects, uses and shares your personal information when you use this website and our associated websites (collectively, the “Websites”), the measures it adopts to ensure that your personal information is safe and lays down your rights to access, update and delete your personal information.

### **1. The information that Noggin collects and processes**

1. Noggin collects and processes the following information:
  - a. the information that you provide when creating your account or interacting with Noggin, such as your name, email address, phone number, billing information and any other information that you provide to Noggin.
  - b. your IP address, the browser you use and its version, information on how you use the Websites and the content that you generate on the Websites.

### **2. Cookies**

We may use cookies to improve your experience when using the Websites, to personalise the Website’s pages, to remember your preferences or to track your visits. By using the Websites you agree to our use of cookies.

### **3. How Noggin uses your information and for how long it retains your information**

1. Noggin uses the information that you provide to contact you. Noggin may contact you, for example, to provide you information on your Pod account or our

services, to request your feedback or to promote our services or the services of our partners.

2. Noggin uses the information you provided us with to allow you to use the Websites, to process orders and payments, to offer you technical support, to create your Pod account and allow you to access it.
3. Noggin uses your information to protect the security of its network and prevent abusive behaviour.
4. Noggin will retain your information as long as it is relevant for the purposes for which it uses it.

#### **4. Sharing your information**

1. Noggin will never share your information in violation of this Privacy Policy. When required by the law to share your information, Noggin complies with its Government Request Policy.

#### **5. Access, update and deletion of your information**

1. You may request to have access to the information you provided by contacting Noggin at [support@nogginasia.com](mailto:support@nogginasia.com). Noggin will provide access to the personal information you request within a reasonable period of time. Noggin reserves the right to charge a reasonable fee for access requests.
2. You may update the information you provided on the webpage of your Pod Account.

3. You may request Noggin to delete the information you provided by contacting Noggin at [support@nogginasia.com](mailto:support@nogginasia.com). Noggin reserves the right to retain certain information when the law authorises or requires it to do so.

## **6. Security of information**

The transmission of information over the Internet is never completely secure. We'll do our best to protect your personal data, but cannot guarantee the security of your data transmitted to our site; any transmission is at your own risk. We use strict procedures and security features to try to prevent unauthorised access. All information you provide to Noggin is stored on secure servers. Payment transactions are encrypted.

## **7. Privacy policies of third parties**

The Websites contain links to third-party websites. Noggin bears no responsibility for the policies applied by third parties on the collection and use of your information. When you share information with third parties, the collection and use of such information by third parties will be subject to their privacy policies as well as laws applicable to them.
